Qualifications for Scholarship Fund:

- **ACTIVE** Crystal Lake United Methodist Church (ie: attendance, youth group, gifts/support, Sunday School, acolyte, lector, usher).
- Persons of any age may apply: high school graduate, college graduate, training or retraining.
- Initial application to be completed and returned to Scholarship Chairman upon entering school. The initial application will be valid as long as defined career/education program continues.
- Applicants must submit completed "Semester Completion Form" within two (2) months after completing term with verification from college.
- If funds are available, post secondary education for beauty school, technical/trade college, two (2) year college, four (4) year college, will have first consideration. Master's degree programs, seminary, etc. will then be considered.
- Funds will be paid with verification by college to include a term with a 2.0 or better GPA. Verification to include the following information:
 - student name _____
 - hours completed _____
 - name of college _____
 - signature of certified personnel _____
 - college stamp or seal _____

Scholarship Information:

- Amount individual to receive will be based upon the current tuition to a state university and subject to scholarship funds available, but not to exceed 25% of the total cost of the semester. Full time is based on 12 hours per semester. Part-time students will be prorated on an hourly basis.
- The Scholarship Committee will award no more than 5% of value of the Scholarship funds.
- There will be no time limit for obtaining the college degree.
- We will not specify a college to be attended.
- For future semesters, you need apply with completion of the **Semester Completion Form** and verification from the college.
- The money will be awarded directly to recipient and not sent to the college.
- All applicants will be treated fairly.
- If no scholarship is awarded for the year, the interest will stay in the fund for future use.
- The Scholarship Committee will be made up of one administrative council member, the trustee secretary-treasurer, one additional trustee, one education committee member and one at-large church member.
- All decisions made by the committee will be final.
